<u>ORDER</u>

R.C.A. No. 85/2023, Dated: 25.09.2023

**KAKANI SUMATHI**, D/o.Kakani Masthan, D.No.11-33-664, Indira Nagar, Kavali – 524201, SPSR Nellore District who has been selected for the post of Office Subordinate, at Roster Point No. 66 (SC-W) of Cycle-III [the vacated place of Smt Panem Santhi who is selected in OC (SC) in the list-2] is temporarily appointed as Office Subordinate and posted to II Additional District Court, Nellore in the existing vacancy, subject to genuineness of medical certificate.

On joining, the individual is hereby deputed to work in Principal District Court, Nellore until further orders.

- NB: 1. The above mentioned candidate is hereby informed that her appointment is made purely on temporary basis and that it does not confer any right of probation or reappointment and that she will be ousted from service at any time without notice and without assigning any reason.
  - 2. The above orders will come into force with immediate effect.
  - 3. The above mentioned newly appointed Office Subordinate is hereby directed to report for duty before her respective presiding officer immediately and in any case <u>on or before 30.09.2023</u>, failing which she will forfeit all the rights over her appointment.
  - 4. The candidate is directed to produce **physical fitness certificate** issued by the Medical Officer not below the rank of Civil Assistant Surgeon at the time of joining duty.
  - 5. The appointment of the above mentioned candidate as Office Subordinates is made in accordance to the provisions contained in section 4 of Act 2 of 1994.
  - 6. The selection and appointment of the candidate as Office Subordinate is made in accordance with section 4(c) of Andhra Pradesh Regulations of appointments to Public Services and Rationalization of Staff Pattern and Pay Structure Act, 1994.
  - 7. The above mentioned newly appointed candidate is covered by the CONTRIBUTORY PENSION SCHEME ONLY as per G.O.Ms.No.653, 654, 655 Finance (Pen-I) Department, dated 22-9-2004 issued by the Government.
  - 8. The above mentioned candidate is hereby informed that her <u>appointment</u> is made <u>purely subject to the verification of the antecedent</u> and if the antecedent of the candidate is found to be adverse, such candidate will be removed or dismissed from service without serving any notice.
  - 9. The above mentioned candidate is informed that if at all the documents produced by the candidate is found to have been created, manipulated, interpolated or forged in future date, she would be removed/dismissed from the service besides launching criminal prosecution against her.
  - 10. The above mentioned newly appointed Office Subordinate has to give notarized affidavit, at the time of joining duty after receipt of this order stating that she would remain in the post, discharge her duty sincerely, honestly and uphold the dignity of the Judiciary and the concerned presiding officer is directed to forward the same to the Principal District Court, Nellore.
  - 11. The pay of the above mentioned newly appointed Office Subordinate shall be fixed in the time scale of Rs.20,000 61,960 under RPS-2022 issued vide G.O. Ms. No.1, Finance (PC-TA) Department, dated 17.1.2022.
  - 12. The individual is informed that her seniority will be in the order, as directed by the Hon'ble High Court.
  - 13. The individual is directed to submit the revised attestation form, duly filled in triplicate, in the prescribed proforma enclosed herewith, along with one set of self-attested copies of her educational qualification, community and study certificate at the time of her joining to the presiding officer concerned without fail.
  - 14. The candidate in the proceedings now working in other department, if any, is directed to submit relieving certificate from her employer and submit the same in the Principal District Court, Nellore before joining duty.
  - 15. The Judicial Officer is requested to submit report to this court by 11:00 A.M on 3.10.2023 stating that the newly recruited employee is joined or not in her respective court within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
