ORDER

R.C.A. No. 102/2023, Dated: 28.10.2023

 SANAGA KAVITHA, D/o.Sanaga Rajasekhar, Nawabupeta Village and Post, Rapur Mandal, Rapur – 524408, SPSR Nellore District who has been selected for the post of Junior Assistant, at Roster Point No. 8 (ST-W) of Cycle-II is temporarily appointed as Junior Assistant and posted to Principal District Court, Nellore in the existing vacancy, subject to genuineness of medical certificate.

- NB: 1. The above mentioned candidate is hereby informed that her appointment is made purely on temporary basis and that it does not confer any right of probation or reappointment and that she will be ousted from service at any time without notice and without assigning any reason.
 - 2. The above orders will come into force with immediate effect.
 - 3. The above mentioned newly appointed Junior Assistant is hereby directed to report for duty before the presiding officer immediately and in any case **on or before 5.11.2023**, failing which she will forfeit all the rights over her appointment.
 - 4. The candidate is directed to produce <u>physical fitness certificate</u> issued by the Medical Officer not below the rank of Civil Assistant Surgeon at the time of joining duty.
 - 5. The appointment of the above mentioned candidate as Junior Assistant is made in accordance to the provisions contained in section 4 of Act 2 of 1994.
 - 6. The selection and appointment of the candidate as Junior Assistant is made in accordance with section 4(c) of Andhra Pradesh Regulations of appointments to Public Services and Rationalization of Staff Pattern and Pay Structure Act, 1994.
 - 7. The above mentioned newly appointed candidate is covered by the CONTRIBUTORY PENSION SCHEME ONLY as per G.O.Ms.No.653, 654, 655 Finance (Pen-I) Department, dated 22-9-2004 issued by the Government.
 - 8. The above mentioned candidate is hereby informed that her appointment is made purely subject to the verification of the antecedents and if the antecedents of the candidate is found to be adverse, such candidate will be removed or dismissed from service without serving any notice.
 - 9. The above mentioned candidate is informed that if at all the documents produced by the candidate is found to have been created, manipulated, interpolated or forged in future date, she would be removed/dismissed from the service besides launching criminal prosecution against her.
 - 10. The above mentioned newly appointed Junior Assistant have to give notarized affidavit, at the time of joining duty after receipt of this order stating that she would remain in the post, discharge her duties sincerely, honestly and uphold the dignity of the Judiciary and the concerned presiding officer is directed to submit the same to the Principal District Court, Nellore.
 - 11. The above mentioned newly appointed Junior Assistant shall, for the due and faithful performance of duties attached there to, deposit an amount of Rs.10,000/- (Rupees Ten Thousand only) towards security in the shape of FDR duly pledging the same in favour of the District Judge, Nellore, SPSR Nellore District, within 30 days from the date of her joining in the post, as per Rule 22 of A.P.J.M.S.S Rules, 2019, failing which, her probation shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge her from the service, unless she has already been otherwise discharged or reverted.
 - 12. The pay of the above mentioned newly appointed Junior Assistant shall be fixed in the time scale of Rs.25,220 80,910 under RPS-2022 issued vide G.O. Ms. No.1, Finance (PC-TA) Department, dated 17.1.2022.
 - 13. The individual is informed that her seniority will be in the order, as directed by the Hon'ble High Court.
 - 14. The individual is directed to submit the revised attestation forms, duly filled in triplicate, in the prescribed proforma enclosed herewith, along with one set of self-attested copies of her educational qualifications,

- community and study certificates at the time of her joining to the presiding officer concerned without fail.
- 15. The above candidate in the proceedings, if working in other departments is directed to submit relieving certificate from her employer at the time of joining the post and the concerned presiding officer is directed to forward the same to the Principal District Court, Nellore.
- 16. The Judicial Officer is requested to submit report to this court by 11:00 A.M on 5.11.2023 stating that the newly recruited employee is joined or not in court within the stipulated date as mentioned above, so as to submit the information to the Hon'ble High Court.
