

On joining, the individual is hereby deputed to work in Principal Civil Judge's Court (Senior Division), Nellore until further orders.

- NB: 1. The promotee is hereby informed that his promotion is made purely on temporary basis and he will be reverted at any time without prior notice and without assigning any reason subject to existing rules.

2. The above individual shall deposit security for an amount of **Rs.10,000/-** in the shape of FDR duly pledging the same in favour of the District Judge, Nellore, SPSR Nellore District, within 30 days from the date of his joining in the promotion post, as per Rule 22 of A.P.J.M.S. Rules, 2019, failing which, his probation shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him from the service or revert him to the post from which he was promoted, as the case may be, unless he has already been otherwise discharged or reverted.
3. It is hereby informed that his seniority in the promotion post will be fixed as per the date of proceedings, but not the date of joining in the respective post.
