Sri V.Srinivasulu Reddy, Attender, Special Judicial Magistrate of I Class Court for trial of prohibition and excise offences, Nellore working on deputation in VIII Additional District Court, Nellore, who has been selected and promoted as Driver [Light Vehicle], is transferred and posted as Driver [Light Vehicle], VIII Additional District Court, Nellore – vice – Sri K.Parandamaiah, Driver [Light Vehicle] - Transferred.

Sri K.Parandamaiah, Driver [Light Vehicle], VIII Additional District Court, Nellore working on deputation in Principal District Court, Nellore is transferred and posted as Driver [Light Vehicle], I Additional District Court, Nellore in the existing vacancy.

On joining, the individual is hereby deputed to work in Principal District Court, Nellore until further orders.

- NB:
1. The promotee is hereby informed that his promotion is made purely on temporary basis and he will be reverted at any time without prior notice and without assigning any reason subject to existing rules.
 2. The above promotee shall deposit security for an amount of **Rs.10,000/-** in the shape of FDR duly pledging the same in favour of the District Judge, Nellore, SPSR Nellore District, within 30 days from the date of his joining in the promotion post, as per Rule 22 of A.P.J.M.S. Rules, 2019, failing which, his probation shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him from the service or revert him to the post from which he was promoted, as the case may be, unless he has already been otherwise discharged or reverted.
 3. It is hereby informed that his seniority in the promotion post will be fixed as per the date of proceedings, but not the date of joining in the respective post.
 4. The above promotee shall handover and take over complete charge of his post and compliance shall be reported to this court with due certification by the Presiding Officer concerned on or before 18.7.2024. And, explanation regarding non-taking and non-handing over of detailed charge, will not be entertained, at a later point of time. And, the successor of the branch is held responsible for all the latches.
 5. Any issue with regard to handing over and taking over of charge will not be entertained. Any deviation will be considered as mis-conduct.
 6. Any request for change of posting will not be entertained and such efforts will be viewed seriously.
 7. The officer concerned is requested to relieve the individuals, on or before 3.07.2024, without any request.
 8. The above promotee is informed that he submitted an undertaking that he will discharge duties along with the duties which are entrusted to him by the presiding officer and he is also directed to attend his past duties subject to necessity till recruitment of Office Subordinates is made.
 9. The presiding officer concerned is directed to make necessary entries in his service register with regard to his qualifications including driving license.
