## eTrue Copy of Orders/Judgments

"Electronic True Copy of Orders/Judgments" is a software application developed to provide litigants and the Advocates of the parties a form to obtain electronic true copy of orders/judgments available in the National Judicial Data Grid. The main objective of this application is to provide the true copy of order/Judgement at the doorstep of needy person eliminating the requirement of visiting Court for obtaining a certified copy of order/Judgment.

### STEPS TO OBTAIN ELECTRONIC TRUE COPY OF ORDERS/JUDGMENTS

**STEP-1:- Open High Court of Uttarakhand official website** i.e <https://highcourtofuttarakhand.gov.in> on a smartphone, laptop computer etc. with internet connection and Click on "eTrue Copy of Order/Judgments" link available on the right side top menu of the official website of High Court of Uttarakhand. *(On clicking the link, the user will be redirected to eTrue Copy application submission form.)*

**Note:- Kindly ensure that pop up is enabled/allowed for the above link/website.**

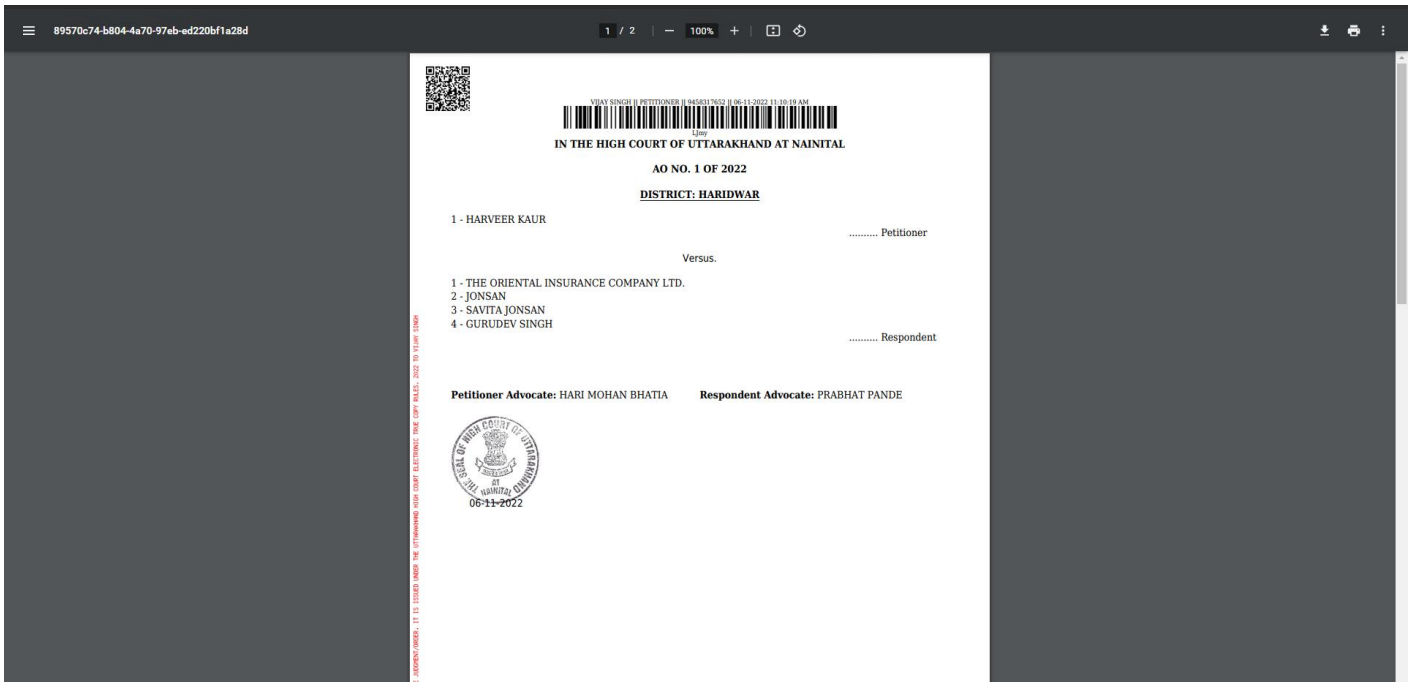
Select Case Type, enter Case number and year and Click "GO". (**A POP UP Window will open showing Parties and the Orders/Judgments**)
