to collect sixty five(65) numbers of e-Waste items (CRT Monitor- 06, CPU -03, Priner(Inkjet)- 1, DMP - 9, PRINTER(Laser)- 4, MFP -1, UPS- 41 ) from its premises in accordance with applicable rule/ guidelines of e-waste items.

2. Bidders are required to submit documentary proof of authorization to collect e-Waste in accordance with the "Guidelines. for disposal of E-Waste from Govt.Offices/ State Govt. Undertaking as per E-waste (Management) Rules, 2016", issued by the Government of Odisha in Forest and Environment Department vide Notification No. E nv. -1-70/2016-1835/F&E dated 25 .01.2018.





3. The bidders are required to participate in the tender along with an authentic copy of authorization document to collect e- Waste items. This may be submitted by registered post addressed to the Registrar (Civil Courts, Balangir . No price quotations should be submitted at this stage.
4. Important Dates/Time:  
**Start Date: 21.02.2025**  
**Last Date: 18.03.2025 at 05.00 P.M**
5. The bid documents received after last date and time of submission shall not be considered.
6. Only those bidders who shall submit valid authorization of State Pollution Control Board, Odisha to collect and/or dispose e-Waste shall be considered eligible for participation.
7. The District Court, Balangir may call for any document at any stage from any of the bidders to ensure proper and fair bidding.
8. Those bidders who are found eligible shall be intimated to submit in person their price bid in sealed cover on the date and time to be fixed in this regard. The scaled cover of all eligible bidders containing price bid shall be opened on the spot in presence of the bidders.
9. The highest bidder shall be awarded with the work of collecting the e- Waste items on such terms and condition as may be fixed in this regard by the Court.
10. District Court, Balangir reserves the rights to award the work order of collecting the e- Waste to such other bidder as it deems proper in case the 1st highest bidder fails to collect the e- Waste in accordance with the work order.
11. District Court, Balangir reserves the right to make any enquiry to examine the correctness of the statement made by the bidders.
12. Bidders shall specifically undertake in their bid document/ intimation that they shall collect and deal with the e-Waste items in strict accordance with applicable rules and guidelines.
13. The authorization document submitted by every bidder must show the validity period of such authorization.
14. The price bid must clearly state the types of e-Waste items for which the bid has been submitted. Only consolidated price bids should be submitted.
15. All communications should be addressed to the Registrar, Civil Courts, Balangir, 767001.

17. All disputes arising out of this tender shall be subject to jurisdiction of Courts at Balangir.
