Notice of Employment

Applications are invited to fill up 04 posts of Peon {02-General, 01- EWS (Gen) and 01-PwBD (Lower Limb)} purely on adhoc basis, on the consolidated pay of Rs. 16,900/- per month i.e. minimum pay scale of the post of Peon, initially for a period of six months or till regular appointments are made, whichever is earlier. The total number of vacancies may increase/decrease due to creation/withdrawal of courts, adjustment of surplus staff or otherwise, during the selection process and no intimation in this regard will be issued separately. "Where no candidate of reserved category is available then appointment will be made from general category".

1. **QUALIFICATION:**

The applicant should have passed Middle standard examination and possesses knowledge of Hindi or Punjabi.

2. **AGE LIMIT**

No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 01.01.2026, provided that relaxation in upper age limit is admissible to the reserved categories as per instructions of the Hon'ble High Court of Punjab and Haryana at Chandigarh and Haryana Government, issued from time to time.

3. **LAST DATE**

Last date for receipt of the applications shall be **13.02.2026 till 5.00.P.M.** No application received thereafter shall be entertained in any case. The applications complete in all respect should reach the below mentioned address on or before the said date:-
