NOTIFICATION

Shimla-2 the 20th July, 2021

No. TPT-A(3)-5/2020.—WHEREAS, as per Section 210 A of the Motor Vehicles Act, 1988, a State Government shall, by notification in the official Gazette, specify multiplier (different

multiplier to different classes of motor vehicles), not less than one and not greater than ten, to be applied to each fine under the said Act and such modified fine, shall be in force in the State and different multipliers may be applied to different classes of motor vehicles as may be classified by the State Government for the purpose of this section.

NOW THEREFORE, in exercise of powers conferred by Section 210 A read with section 200 of the Act *ibid*, the Governor of Himachal Pradesh is pleased to notify modified fines and compounding limits of fines for various offences committed under the provisions of the Act *ibid*, as per the Schedule specified below :—

The Governor, Himachal Pradesh in exercise of the powers conferred by proviso to section 194B(1) of the Act *ibid*, is further pleased to exclude contract carriage, stage carriage, private service vehicle (more than 12 seater excluding driver) and educational institution bus (carrying students more than 14 years of age) from application of the provisions of sub-section (1) of Section 194 (B) of the said Act.

The amount collected as compounding fee will be deposited in the Major Head 0041- Taxes on vehicle, 101-Receipt under the Motor Vehicle Act, 04-Penalty. In exercise of the powers vested under section 210A of the Act *ibid*, the Governor, Himachal Pradesh is also pleased to notify the amount of modified fine on conviction for any non-compoundable offence under this Act, shall be the amount calculated after applying multiplier of one and half (1.5) to the fine mentioned in the relevant provision of this Act.
