Chairperson:-

- a) Qualification: A Chairperson of the HHRC will be a retired Chief Justice/Judge of a High Court.
- b) Term: Three years or upto the age of 70 years whichever is earlier.
- c) Salary and allowances: The salary and allowances, will be equal to Chief Justice of Punjab and Haryana High Court subject to reduced pension benefit, if any.

Member:-

- a) Qualification: A Member of the HHRC will be a retired Judge of High Court or District Judge in the state with a minimum of seven years experience as District Judge.
- b) Term: Three years or upto the age of 70 years whichever is earlier.
- Salary and allowances: Salary and allowances, will be equal to a Judge of Punjab and Haryana High Court subject to reduced pension benefit, if any.
