Subject: Special Lok Adalat before Hon'ble Supreme Court of India on and w.e.f. 29<sup>th</sup> July, 2024 to 3<sup>rd</sup> August, 2024.

Sir,

In reference to the captioned subject, I have the honor to inform you that the Hon'ble Supreme Court is organizing a Special Lok Adalat for cases pending before it from 29.07.2024 to 03.08.2024. I have been appointed as the Nodal Officer for the supervision of this Special Lok Adalat for the State of Himachal Pradesh. The Hon'ble Supreme Court has sent a consolidated list of cases pertaining to Himachal Pradesh (Annexure - 'A'), which have been identified for settlement before Special Lok Adalat.

In this context, the Hon'ble Executive Chairman has directed me to request your compliance with the following directions:

- a) The cases identified for the Special Lok Adalat have been segregated district wise. A copy of the list of such cases is also enclosed for your reference (Annexure-'B'). The same may kindly be got cross-checked at your own level.
- b) The Secretary of concerned District Legal Services Authority will be responsible to coordinate and manage the work regarding Special Lok Adalat. His telephone number be displayed on the website of the district court.
- c) The District Legal Services Authorities shall contact the parties concerned (telephonically, through PLVs, by issuing notices, through local advocates of the parties, etc.) in order to explore amicable settlement.'
- d) The notices to the parties concerned shall be got served through process serving agencies of the courts.
- e) Pre-Lok Adalat sittings can be arranged by the District Legal Services Authorities in physical/virtual/hybrid modes by using the video conferencing facilities of the District Courts.

- f) The parties will be informed that they can contact their respective District Legal Services Authority to list their cases for amicable settlement before the Special Lok Adalat.
- g) The Secretaries, District Legal Services Authorities will supervise Pre-Lok Adalat sittings, arranged through mediators or counselors.
- h) The list of cases pertaining to your district can also be displayed on the website of your District Court.
- i) Publicity about Special Lok Adalat will be made through vernacular newspapers, local media and local cable networks of your district.
- j) Notices about the Special Lok Adalat will be displayed on the boards of the District Bar Association(s), District Legal Services Authorities, and Sub-Divisional Legal Services Committees.
- k) In Motor Accident Claim Cases, a meeting can be arranged with the officers of Insurance Companies concerned.
- l) The first action taken report be sent to this Authority on or before 15<sup>th</sup> June, 2024.
