## ORDER

Vide order dated 22.07.2021, passed in CRM-M-21526 of 2021, titled as Vijay Kumar @ Vijay Vs. State of Punjab, the Hon'ble High Court has been pleased to issue the following directions to the Courts below in the States of Punjab, Haryana and U.T. Chandigarh:

- "1. That in each and every case when an application for bail is made before the Courts bellow, under any of the provisions of the Code of Criminal Procedure, it shall be mandatory to mention in the application as to whether such or similar application for bail under any of the provisions of Code of Criminal Procedure has or has not been made before any Superior Court, and if at all, a Superior Court has been approached for similar relief, the result thereof.
- application which does not contain the Any information shall be aforementioned not accepted/entertained and would for be returned resubmission with the necessary information.
- 3. It needs to be also certified that the Public Prosecutors/prosecuting agency shall be duty bound to apprise the Court concerned (before whom the bail application has been moved), after collecting the necessary information from the investigating officers with respect to the filing of any application/petition before any Court, seeking concession of bail under the provisions of Code of Criminal Procedure and the result thereof.
- 4. In case of any lapse/default on the part of the investigating agency/prosecution in the said regard, it would be construed to be a fraud played upon the Court, which would invite departmental as well as penal action against the erring parties/officials, as the case may be."

In compliance of the directions issued by Hon'ble High Court vide letter No.972/Spl./Gaz.II.17 dated 09.08.2021, this office vide its letter bearing Endst. No.15761-65 dated 10.08.2021 circulated the copy of order dated 22.07.2021 passed by Hon'ble High

Court in CRM-M-21526 of 2021, titled as Vijay Kumar @ Vijay Vs. State of Punjab to all the quarters concerned, but the officials of the Suvidha Centres of this sessions Division have brought to the notice of the undersigned that the aforesaid directions are not complied with by some of the parties/their counsel by letter and spirit.

In view of the above, it is again directed that these mandatory directions be complied with by all the concerned by pleading these facts in the bail application duly supported by an affidavit of the concerned to that effect and in case of non-compliance thereof, the bail application shall not be accepted/entertained.

All concerned be informed accordingly.
