Educational Qualification:

The candidate should have possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized University. He/she should have passed matriculation examination with Hindi as one of the subject and must have proficiency in operation of Computers.

Age:

No person shall be recruited to the service, if he/she is less than 18 years or is more than 42 years of age as on 01.01.2024. However, age relaxation for reserved posts shall be applicable as per reservation policy framed by Government of Haryana, from time to time.

Mode of Selection for the post of Clerk:

The selection for the post of Clerks shall be made on the basis of a written examination in the subjects of (i) English Composition and (ii) General Knowledge consisting of 50 marks each. No candidate shall be considered for appointment unless he/she obtains 40% marks in aggregate (33% qualifying marks in each subject) in the written examination. The candidates who would qualify the prescribed written test shall be called for Computer Proficiency Test. The candidate will have to qualify Computer Typing Test in English at the speed of 30 w.p.m.

The selection for the aforesaid posts shall be made strictly in accordance with the provisions of Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997.


