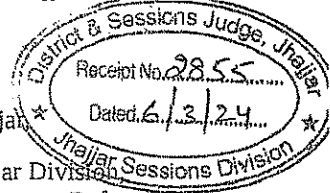


OFFICE OF CHIEF JUDICIAL MAGISTRATE, JHAJJAR
