In case any judicial Magistrate, who is the Duty Magistrate proceeds on leave on any working day, he/she shall intimate in writing to the next Duty Magistrate about his/her leave under intimation to the undersigned and Ld. District and Sessions Judge Jhajjar and the next officer in duty roster shall be the Duty Magistrate.

In case any Judicial Magistrate, who is the duty Magistrates proceeds on leave on any Sunday or holiday, or after court hour he/she shall make an alternate arrangement for duty work in his/her absence and obtain consent of the officer in writing under intimation & prior approval of Ld District and Sessions Judge Jhajjar. An intimation in this regard shall also be communicated by the officer to the undersigned. In case the CJM/ACJM are busy in protocol duties/official meetings the next presiding officer on duty shall do the duty work.


In case the Duty Magistrate and the next Duty Magistrate happens to be on leave or is otherwise absent, then the duty work shall be attended by the officer available on station next junior to Duty Magistrate.

In case all the Magistrates at Bahadurgarh are on leave, they shall make alternative arrangement for performance of duty work after proper intimation in writing to Ld District and Sessions Judge Jhajjar along with the Duty Magistrate at Jhajjar and the undersigned.

The duty roster has been prepared according to directions of Hon'ble High Court, Punjab and Haryana, Chandigarh, issued vide letter no 2020/Gaz.II dated 22.01.1993. and in compliance of letter no. 6067 Dated 01.05.2020 and letter no. 6191 dated 02.05.2020 of Ld. District & Sessions Judge, Jhajjar. In case the duty roster for next month is not prepared, the present roster shall be considered as such.

As conveyed by the Registrar General, Hon'ble Punjab and Haryana High Court, through letter No. 42423/Gaz.II(17) dated 28.10.2010, the Area Magistrates shall strictly attend to all kinds of matters i.e the remand matters, receiving of special reports, production of case property etc. relating to the area of jurisdiction failing in the police station allotted to them, even beyond Court hours, on all court working days, and they are at station.

The duty period on a particular day shall be up-to beginning of the court hours on the next day.
