## PUBLIC NOTICE

The candidates who have ticked more than one category shall have to opt one category at the time of interview. This however, shall be subject to meeting age criteria.

With respect to the candidates who had not applied on the prescribed proforma or submitted unsigned applications are also allowed to appear in the interview on provisional basis subject to furnishing the requisite undertaking as per the specimen enclosed as "Annexure P" as well as the prescribed application form at the time of interview failing which they shall not be allowed to appear in the interview.

All the candidates are also required to bring their original testimonials/ certificates/ category proof etc. as the case may be, for

documents verification along-with one photo ID proof at the time of interview failing which they shall not be allowed to appear in the interview.
