- a) The reservation for different categories and related matters will be regulated as per the provisions of the Punjab Subordinate Court Establishment (Recruitment and General Conditions of Service) Rules, 1997 as amended from time to time and other guidelines/instructions issued by Punjab Government which are duly

adopted by the Hon'ble Punjab and Haryana High Court for the employees working in Subordinate Courts of Punjab State.

- b) Number of vacancies may be altered without any prior notice.
- c) Only EWS, Scheduled Caste, BC/OBC, Ex-Serviceman, Freedom Fighter candidates of Punjab domicile are eligible for seeking benefit of reservation. Reservation shall be provided to candidates belonging to PwBD category, as per rules. Candidates who belong to reserve category shall attach copy of their respective category certificate duly issued by the competent authority failing which he/ she will be considered in General Category.

SELECTION CRITERIA

Candidates shall have to take a written examination in the following subjects: -

- No candidate shall be considered for appointment unless he/she obtains 40% marks in aggregate in the written examination.

Thereafter, shortlisted candidates (on the basis of the merit list) will be called for Computer proficiency Test (Word Processing and Spreadsheet) equal to the ten times of the number of vacancies.

DATE, TIME & VENUE OF TEST

The written test in respect of the advertised posts would be conducted tentatively in the month of July, 2026. However, exact details (date, timing, venue etc.) of the written test as well as computer proficiency test will be displayed on the notice board of the Office of the undersigned as well as on the website <https://ludhiana.dcourts.gov.in>. Candidates in their own interest are advised to check the website, frequently. **No separate/ individual information will be given to any candidate by this office.**

NOTES

1. Applications on the prescribed proforma should be legibly filled in CAPITAL LETTERS with complete particulars. The candidate shall submit the duly signed application form, bearing the date thereunder, along with all the requisite supporting documents. The application sent by post must be enclosed in an envelope superscribed as "APPLICATION FOR THE POST OF CLERK ON ADHOC BASIS". Further, each envelope shall contain only one application.
2. The forms which are wrongly filled up or incomplete information will be summarily rejected. No correspondence in this regard will be made by this office.
3. All applicants irrespective of their category i.e. General or reserved category, can submit only one application for a particular category. In

case, an applicant submits more than one application, only latest application will be considered

4. The certificate for the claim of reservation must be issued by the competent authority. The said certificate must be latest. Candidate shall also possess the domicile/residence certificate issued by the competent authority.
5. All particulars including category and sub-category once filled by the applicant shall be sacrosanct and no change shall be permitted at any stage of the recruitment process so the applicants are advised to fill all their particulars after taking due care and precaution
6. The Reservation for Economically Weaker Sections of Punjab shall be governed by instructions of the Punjab Government bearing Letters No. 1/3/2019-RCI/120 dated 28.05.2019, 8/2/2019-3PP1/1548834/1 dated 13.08.2019 and 1/16/2019-RC1/1566148/1 dated 05.09.2019 and subsequent amendments, if any.
7. The Reservation for Women of Punjab shall be governed by instructions of the Punjab Government bearing Letter No. 11/5/2017-1SS(3SS)/2594 dated 28.10.2020 and Letter No. 11/5/2017-1SS(3SS)/3268 dated 31.12.2020 and subsequent amendments, if any.
8. The Reservation for Freedom Fighter and their wards and grandchildren (paternal as well as maternal) of Punjab shall be governed by instructions of the Punjab Government bearing Letter No. 9(13)-3P11-84/5822 dated 04.04.1985 and Letter No. 13/16/20103FF/959 dated 28.07.2011 and subsequent amendments, if any.
9. The reservation for the Persons with Benchmark Disabilities of Punjab shall be governed as per the Punjab Government letters No. 01/01/2017-3DC/1588894/1 dated 03.10.2019, 03/09/2021-3DC/452 dated 04.06.2021 and 03/09/2021-3DC/505 dated 20.12.2022 and subsequent amendments, if any.
10. This office will not be responsible for any postal delay or wrong delivery, whatsoever. Applications received after due date shall not be entertained.
11. The candidates are required to bring at least one photo ID proof on the day of test alongwith other document(s) as asked for by this office at a later stage, if any.
12. No separate TA/DA will be given to the candidates appearing for test.
13. The scheduled test can be postponed/ cancelled, without any prior notice. In that case, next date of test shall be displayed on the notice board of this Office as well as on the website, stated above. No separate intimation will be sent to any candidate.
14. The admission of applicants at all stages of the recruitment process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary proof in support thereof as well as verification of their documents. If on

verification at any stage before or after the said process and even after the completion of selection process, if it is found that an applicant does not fulfil any of the eligibility condition, his/her candidature shall stand cancelled without any further notice and with consequential effect. If any document/ certificate of the candidate is found false or forged, further action shall also be taken as per law besides cancellation of candidature.

15. The number of vacancies as shown above are tentative and may be increased or decreased in future due to administrative exigencies and this office reserves the right to prepare a Merit List/ Waiting List of the candidates with more than actual/tentative number of vacancies.
16. In case the sufficient/required number of candidates are not available in any of the respective reserved category, then the vacancies left unfilled in such reserved category may be filled by this office from amongst the candidates available in unreserved category, subject to their availability.
17. Merely satisfying the eligibility criterion does not entitle a candidate to be selected. This office shall reserve the right to alter/modify or change any of the terms and conditions including selection criteria etc. spelt out in the public notice/employment notice.
