PUBLIC NOTICE

Employment Notice No.2 of 2026

In continuation of the Public Notice dated 22.05.2026 published in the newspaper Punjabi Tribune read with Employment Notice No. 2 of 2026 and the Public Notice dated 06.07.2026, it is informed to all the concerned that the written examination for the advertised posts shall be conducted on 19.07.2026 and the roll number-wise list of provisionally eligible candidates (Annexure 'AA'), admit cards (Annexure 'BB'), list of rejected candidates (Annexure 'CC') and list of examination centres (Annexure 'DD') are available on the official website i.e. "<https://ludhiana.dcourts.gov.in/notice-category/recruitments/>"

Candidates are instructed to download the PDF file containing admit cards and print the page that includes their details. The admit card which must have a recent passport-sized photograph (either be countersigned by a Gazetted officer or self-attested by the candidate) affixed to it, should be presented during the written exam. Candidates are further asked to carefully read the instructions mentioned in the admit card to avoid any confusion.

The written test would be conducted at the venues as appearing in Annexure 'DD' available on the website and the same would commence on 11:00 AM and would be of two hours duration. The reporting time would be 09:30 AM and no candidates should be allowed to enter the venue after 10:45 AM. Candidates who belong to PwBD category may submit their option for choosing scribe/ assistant by 16.07.2026 as per the instructions issued by the competent authority from time to time.

It is clarified that the candidates who have failed to remove the discrepancies as per directions issued vide Public Notice dated 06.07.2026, which are mentioned in the various columns of the list, are permitted to appear in the written test on a provisional basis. However, it is mandatory to remove any objections related to their documentation during the subsequent Computer Proficiency Test, should they advance to that stage.

Candidates who applied under the EWS category but have not furnished the Income and Asset Certificate for the year 2026-27 have been granted an opportunity to submit the said certificate, in terms of the Public Notices dated 22.05.2026 and 06.07.2026 read with Employment Notice No. 2 of 2026, physically in this office on or before 17.07.2026, failing which they shall, ipso facto, be considered under the General Category with all consequential effects

Further, during the scrutiny of applications, it has been observed that a large number of candidates claiming reservation have not submitted the requisite Residence/ Domicile Certificate along with their application forms. It has been noted that some candidates could not obtain the said certificate owing to the strike at the Sewa Kendras. Accordingly, in the interest of fairness, natural justice and to ensure that otherwise eligible candidates are not deprived of an opportunity on account of a curable procedural deficiency, such candidates are provisionally permitted to appear in the written examination. However, if any such candidate qualifies the written examination, he/she shall be required to produce the requisite Residence/ Domicile Certificate on the date of the Computer Proficiency Test (CPT).

It is further clarified that in view of the above, the condition regarding the date of issuance of the Residence/Domicile Certificate stands relaxed and any valid Residence/Domicile Certificate issued by the competent authority on or before the date of the Computer Proficiency Test (CPT), which shall be notified in due course, shall be accepted.

Furthermore, candidates are advised to regularly check the official website for updates in their own interest and no separate communication of any kind would be made by this office.
