## OFFICE OF THE DISTRICT AND SESSIONS JUDGE, JALANDHAR ORDER

In pursuance of the instructions contained in Hon'ble High Court letters No. 1165 SPL - Gaz. II.(12G) dated 09.05.2024 and No.1237/ Spl./ Gaz.II.(12G) dated 04.05.2013, all the Subordinate Courts shall remain closed for Civil work from 01.06.2024 to 30.06.2024 (except urgent matters). However, there will be regular criminal work from 01.06.2024 to 15.06.2024, during summer vacations and from 16.06.2024 to 30.06.2024, there shall be 'No work period' in the Subordinate Courts (except urgent matters).
