**STEP II** Click on the link of the Concerned Court as per list of links shown below,

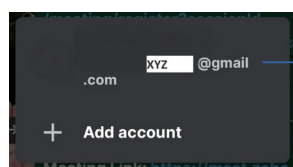
**STEP III** After Clicking on the Court Link Guest Login window will appear here you have to enter your name, Mobile no. and PIN (123456) then click on Join.

# STEPS TO CONNECT THE VIDEO CONFERENCING USING “GOOGLE MEET” AT JALANDHAR SESSIONS DIVISION

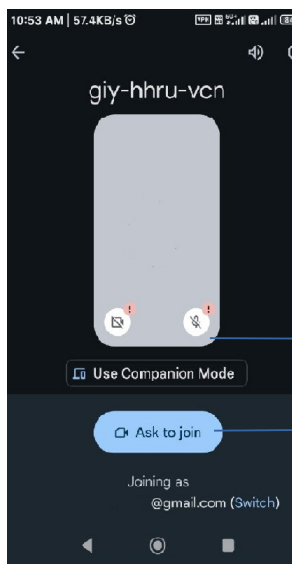
