**NOTIFICATION**

Whereas, the Hon'ble Supreme Court of India vide judgment dated 15.12.2022, in the matter of Civil Appeal No. 9322 of 2022, titled as "Gohar Mohammad Versus Uttar Pradesh State Road Transport Corporation & Ors. has inter-alia directed the Registrar General of the High Courts to issue Distribution Memo attaching the Police Stations to the Motor Accident Claims Tribunals from time to time to ensure the compliance of the Motor Vehicles (Amendment) Act, 2022 and Motor Vehicles (Amendment) Rules, 2022.

And, the Investigating Officer after the registration of F.I.R. shall submit the First Accident Report (FAR) within 48 hours to the Claims Tribunal and Interim Accident Report (IAR) and Detailed Accident Report (DAR) subsequently within the time limits subject to the compliance of the provisions of the aforesaid Rules.

Now, therefore, the Division-wise Police Stations in the State shall be attached to the Motor Accident Claims Tribunal(s) (MACTs) as specified below:-
