

With reference to the subject noted above, I am directed to inform you that the Hon'ble Court has been pleased to approve the mutual transfer of following employees of your respective judgeships.



It is further to inform you that the above mentioned mutual transfers are being made subject to the condition that the seniority of transferred employees in the new District shall be determined as per the law laid down in judgment of the Hon'ble Court in Writ Petition (S/S) No. 1127 of 2011, titled as *Rakesh Kumar Tripathi and others Vs. Hon'ble High Court of Uttarakhand* and affirmed by Division Bench by judgment dated 21.08.2017 passed in Special Appeal No. 179 of 2013 titled as *Sanjay Singh Vs. Hon'ble High Court of Uttarakhand and others* and that they will be placed at the bottom of the cadre. However, their last pay drawn from the post they held at previous place of posting will be protected. They will get benefit of past services which they have rendered at their previous place of posting for eligibility criteria of ACP and promotion etc.

3. No transfer allowance shall be admissible to the above mentioned transferred employees. The District Judges are requested to relieve these employees forthwith. This order will come into force with immediate effect.

4. You are therefore, informed accordingly to do the needful in this regard.
