She is relieved from her present assignment in the afternoon of 02.01.2025 and directed to join her duties in Judgeship Almora, accordingly.

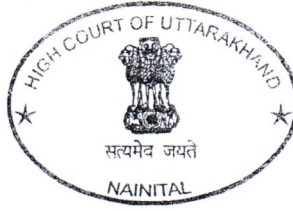

Sir,

With reference to the subject noted above, I am directed to inform you that the Hon'ble Court has been pleased to transfer the Group-C and Group-D employees of District Judiciary in Phased-Manner.

2. Pursuant to above, in Second Phase, applications of employees, who have requested for transfer from different Districts in District Judiciary including Family Courts to Districts **Almora, Bageshwar, Chamoli, Champawat and Nainital** have been considered by the Hon'ble Court. List of all the transferred employees is enclosed herewith.

3. It is further to inform you that the above mentioned transfers are being made subject to the condition that the seniority of transferred employees in the new District shall be determined as per the law laid down in judgment of the Hon'ble Court in Writ Petition (S/S) No. 1127 of 2011, titled as Rakesh Kumar Tripathi and others Vs. Hon'ble High Court of Uttarakhand and affirmed by Division Bench by judgment dated 21.08.2017 passed in Special Appeal No. 179 of 2013 titled as Sanjay Singh Vs. Hon'ble High Court of Uttarakhand and others and that they will be placed at the bottom of the cadre. However, their last pay drawn from the post they held at previous place of posting will be protected. They will get benefit of past services which they have rendered at their previous place of posting for eligibility criteria of ACP and promotion etc.


