- IX. Services of Banking Institutions and other Financial Institutions;
- X. Services under Mahatma Gandhi National Rural Employment Guarantee Act, 2005;
- XI. New connections of LPG and Supply of LPG or Refills and its connected matters;
- XII. Services relating to issuance of Aadhar Card, Ration Card, Voter Identity Card and Below Poverty Line (BPL) Cards;
- XIII. Services relating to the Old Age Pension, Widow Pension and Unemployment Allowances;
- XIV. Services under the Public Distribution System (PDS) in the State;
- XV. Mobile Phone and Internet Service; and
- XVI. Any service which the Central Government or the State Government, as the case may be, may, in the public interest, by notification, declare to be a public utility service for the purposes of chapter-VIA of the Legal Services Authorities Act.

Sitting Fee: He/she shall be entitled to sitting fee of Rs. 1,500/-per sitting.

Conveyance Allowance: Rs.5000/- per month as conveyance allowance for the purpose of attending the sittings of Permanent Lok Adalat.

Place of posting: The selected candidate will be appointed in the office of Permanent Lok Adalat (Public Utility Services), Bhubaneswar.
