In view of the minutes dated 14.03.2021 of the Committee for engagement of daily wage workers (purely on temporary basis) to meet the required services of Group-'D' employees of the Judgeship of Khurda, the following Order is passed.

The candidates named below are directed to report before the Registrar, Civil Courts, Khurda at Bhubaneswar on 16.03.2021 Forenoon for their engagement on daily wage basis as per the District Court Notice No.04 dated 09.03.2021 with the following conditions that

- (1) Under no circumstances they will claim any right of reengagement what so ever at any point of time.
- (2) They shall be removed from the engagement at any time, without notice, if their service is found not satisfactory.
- (3) Their engagement will continue till the finalisation of Rules for Recruitment of Group-'D' posts in the District and Subordinate Judiciary or till 06 (Six) months whichever is earlier.


