ADVERTISEMENT: FOR SELECTION OF PARA LEGAL VOLUNTEERS

Dated, the 14th day of May, 2019

Applications in the prescribed format are invited from the suitable desirous local residents of Khurda District along-with two numbers of colour passport size photographs and one self-addressed envelope for selection of PLVs (for a period of one year from the date of appointment), who are willing to serve as a Para legal volunteer. The applicants must have the following eligibility for being selected as Para legal volunteers:

#### Eligibility Criteria:

- 1. He/ She must be a citizen of India.
- 2. He/ She shall be literate, at least passed matriculation examination or its equivalent examination, with a capacity for overall comprehension.
- 3. He/ She should be able to speak, read and write Odia.
- 4. He/ She should be a major having completed the age of 18 years on the date of advertisement.
- 5. He/ She should be of good moral character.

## Groups from Whom Para Legal Volunteers can be selected

- Teachers (Including Retired Teachers)
- Retired Govt. Servants and Senior Citizens
- M.S.W Students and Teachers
- Anganwadi Workers
- Doctors/ Physicians
- College Students & Law Students (Till they enroll as lawyers)
- Members of non-political, service oriented NGOs and Clubs
- Members of Women Neighborhood Groups, Maithri Sanghas and other Self Help Groups including marginalized/vulnerable groups.
- Educated prisoners with good behavior, serving long term sentences in prisons.
- Any other person whom the DLSA deems fit to be identified as PLVs.

## Procedure for submission of Application-

The application form duly signed along with the required documents and self-attested true copies of certificates in a closed envelope must reach the Office of the Chairman, District Legal Services Authority, Khurda at Bhubaneswar, At- ADR Centre, Near Sub-Registrar Office, BJB Nagar, Bhubaneswar-14 on or before 30.05.2019 either by Post or in person during the office hours on each working day.

N.B.:-

- (i) The Envelope containing the application and other required documents should be super scribed with the words "APPLICATION FOR SELECTION OF PARA LEGAL VOLUNTEERS" on its top.
- (ii) The applicants are required to submit their application being duly filled in and signed by their own hand furnishing the required particulars as per the format given below.
- (iii) Noncompliance of any of the requirements mentioned in the advertisement shall entail rejection of his/her application out-rightly. Application if found defective and/or incomplete in any respect and received in the office after the last date by any means, shall be summarily rejected.
- (iv) In case of receipt of large number of applications, the Selection committee of District Legal Services Authority reserves the right to short list the candidates.

#### Method of Selection:

The selection of the Para legal volunteers shall be made by a selection Committee headed by the Chairman of the District Legal Services Authority. The Para legal volunteers shall be selected through an interview/ personality test. The Selection Committee is entitled to use its discretion and shortlist the number of candidates for interview depending upon the number of application received. The basis of screening of elimination will be decided by the Selection Committee after getting the application.

Preference shall be given to women while selecting PLVs. Representation from suitable applicants belonging to S.C/ S.T/ Minorities and other backward classes shall be ensured. Preferably PLVs shall be selected from persons, who do not look up to the income they derive from their services as PLVs, but they should have a mind set-up to assist the needy in the society coupled with the compassion, empathy and concern for the upliftment of the marginalized and weaker section of the society.

In case of any objection regarding selection of Para legal volunteers, the decision of the Chairman, District Legal Services Authority, Khurda at Bhubaneswar shall be final and binding on all concerned.

List of the applicants shortlisted for interview will be notified in the office Notice Board as well as be uploaded in the District Court website <a href="https://districts.ecourts.gov.in/">https://districts.ecourts.gov.in/</a> india/odisha/khordha.

- The appointment of PLV is not a job and it does not carry any salary, remuneration or wages except honorarium fixed by DLSA from time to time.
- 2. No TA/DA will be provided to the applicant for appearing in the interview.
