Applications in the prescribed format (attached herewith) are invited from interested retired Group-D employees not above 65 years as on 31.03.2017 and having good service records and physical fitness to fill up the vacant posts of "Group-D" employees for a spell of six months in a monthly consolidated remuneration of Rs. 4,000/- (Rupees four thousand) only in the Khurda Judgeship pursuant to the letter of the Hon'ble High Court of Orissa, Cuttack vide letter No.- 3468(30), dt. 25.03.2017.
2. The contractual engagement shall be made for a period of 6 months subject to satisfactory performance not beyond the age of sixty five years in any case.
3. The appointee has to discharge such duties and in such a manner, as may be prescribed by the District Judge, Khurda at Bhubaneswar from time to time.
4. The retired employees against whom a criminal prosecution or departmental proceeding is contemplated or who has been penalised for misconduct during the period of regular service shall not be considered for re-engagement.
5. The engaged employee shall be subject to and be governed by the Rules applicable to the Govt. Servants.
6. In case any employee desires to resign from engagement, he/ she may do so by giving a notice of one month in writing to the Registrar, Civil Courts, Bhubaneswar. After expiry of the notice period, the employee may be relieved after handing over charge to any other employee, as decided by the office.
7. District Judge Khurda reserves the right to reject any/ all applications without assigning any reason thereof.
