### **EMPLOYMENT NOTICE**

Applications are invited from eligible candidates for **08 (Eight) posts of Peon on ad-hoc basis** in Sonipat Sessions Division (District Courts at Sonipat) in the consolidated pay of Rs. 16,900/- per month, for a period of six months or till the regular appointments are made, whichever is earlier. The essential eligibility, reservation of categories and age limit for the post is as under:-

**Eligibility:** Having qualification of middle standard pass and knowledge of *Hindi or Punjabi*.

**Age Limit:** 18 years to 42 years as on 01.01.2026. Relaxation as fixed by the Government of Haryana from time to time.

#### **Last date for submission of application and other information**

The last date for submission of applications in the office of District and Sessions Judge, Sonipat, is 16.02.2026, by all modes (through postal department/courier services or by-hand) and no application will be accepted/ entertained after the last date. Applications of the candidates should contain name of post, name of the applicant, father's name, date of birth, educational qualification, gender, reserved category, experience (if any), present postal address with contact numbers, permanent address, e-mail ID etc. Format of the application form is also available on the website of this office. One latest passport size colored photograph must be affixed on the application form and self-attested photocopies of educational documents and certificates regarding category, experience etc. must be attached with the application form. The candidate, who does not attach the document of reserved category, shall be treated as a candidate of general

category. Application forms, which are incomplete and are without the required documents, will be summarily rejected.

The applicants may send their applications by post/courier service or submit the same by hand in the office on each working day from 10:00 a.m. to 05:00 p.m. up to 16.02.2026. It is made clear that the applications received after due date shall not be entertained in any manner. This office will not be responsible for late distribution/non-distribution of applications of the candidates by postal department/courier service.

It is also made clear that the number of vacancies may be increased or decreased with or without prior notice, as per requirement. This office reserves the right to adopt justifiable criteria for short-listing the candidates in case a large number of applications are received.

Willing candidates working in Government/Semi-Government/Corporations/Boards are directed to submit their applications through proper channel.
