It is hereby notified that the applications are invited from Legal Practitioners for empanelment as Panel Advocates.

#### **Method of Selection:**

Selection of the Panel Advocates will be made by the Selection Committee headed by the Hon'ble Chairman, District Legal Services Authority, in accordance with National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010.

#### **Eligibility:**


- The Advocate having more than 3 years experience as a legal practitioner at the Bar eligible for being selected as Panel Advocate.
- The Advocate having less than 3 years experience may also apply if he/she is extraordinarily good so as to work in the Legal Services Institutions.

#### **General Instructions to the Applicants:**


- The applications are made available in the office of District Legal Services Authority, District Court Complex, Mangaluru, D.K and in District Court website as well.
- The applications shall be submitted on or before **03.05.2025**. Any applications received after the aforesaid date will not be considered.
- The applications shall be accompanied with proof of professional experience issued by the Bar Association and two recent passport size photographs.

4. The applicants shall read all the instructions carefully before submitting the applications.
5. The applicants shall provide mobile number and valid e-mail ID for communications.
6. The decision of the Chairman, DLSA will be final as regards the eligibility for selection.
7. The list of eligible applicants shortlisted for interview will be published in the District Court's website as well as in the office of DLSA, Mangaluru.
8. The applicants shall have to appear for interview, if called for at such time and place decided and notified by DLSA.
9. Selection of Panel Advocates is purely on the basis of their eligibility and satisfaction of the Selection Committee. Only after obtaining Panel of Advocates approved by the Hon'ble Executive Chairman, KSLSA, the final list of Panel Lawyers will be displayed in the District Court's website and notice board of office of DLSA.
10. After the selection, if it is found that the performance of any Panel Advocate is not satisfactory and if such advocates acts contrary to the object and spirit of the Act and Regulations, the Legal Services Institution will take appropriate steps including removal from the panel.
11. If the Panel Advocate receives any fee, remuneration or any valuable consideration in any manner from the person to whom he/she has rendered legal services under Regulations, he/she will be disqualified and also will be liable to be removed from the panel.
12. The Panel Lawyers shall undergo training periodically as per modules prepared by the National Legal Services Authority and the State Legal Services Authority. The DLSA will organize training programmes for panel lawyers.
13. The approved Panel of Advocates will be in existence for a period of 3 years and it will be reviewed and updated periodically by the Hon'ble Chairman of DLSA, keeping in view the performance of the Panel Advocates.
