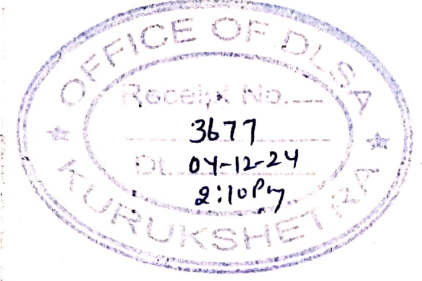

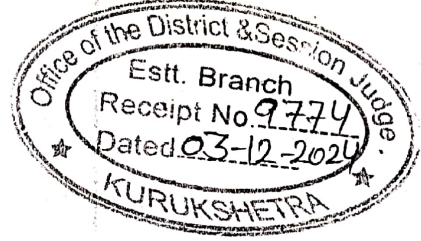

Subject: Regarding implementation of Cost Collection through QR Code
Sir/Madam,

It is apprised that for the benefit of the litigants, the facility of cost collection through QR Codes was launched from Chandigarh Judicial Academy, Chandigarh on 17th November, 2024 by Hon'ble Judges of Supreme Court of India in the benign presence of Hon'ble Judges of High Court of Punjab and Haryana, Chandigarh, High Court of Jammu & Kashmir and High Court of Himachal Pradesh.

For the convenience of the General Public, Hon'ble Executive Chairman of this Authority is pleased to approve following guidelines for all the District Legal Services Authorities for necessary compliance:

- a) The QR Code standees should be placed in all the Courts of the District with the Reader, so that the litigants can deposit the Cost imposed by Hon'ble Courts there and avoid the hardship of visiting ADR Centres. However, it is made clear that no District Legal Services Authority should refuse the existing modes of Cost receipts as this facility is an additional facility for the benefit of the litigants;
- b) The QR Code of the concerned District should be hosted on the website of e-court of the respective District Courts;
- c) Wide publicity be given for the said service, so that maximum people are able to use the facility. The District Legal Services Authority may setup Helpdesk, install banners, etc. and expenditure of Banners or other means (except



Honorarium) may be incurred from Cost and Interest Account of the respective District Authority;

d) In case any District Legal Services Authority wants to get additional standees with QR Codes printed or replacement of damaged Standees, the expenditure for the same may be incurred from Cost and Interest Account of the District Authority at their own level.

e) All the QR Codes will be hosted on the website of HALSA and litigants may be informed to avail the facility by visiting website of HALSA (hlsa.gov.in) or website of respective e-courts.

Besides above, it is informed that this Authority had got the Standees Printed for the District Courts and the same is being sent to your District Legal Services Authority through Post in due course.



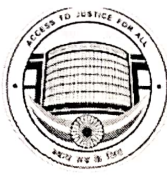
