In view of Rule 15A of "The Bihar Civil Court Officers and Staff (Recruitment, Promotion, Transfer and other Service Conditions) Rule, 2022" willingness are invited for re-employment from all the eligible Class-III & IV Staff of Civil Courts, Bihar, who have superannuated and have not completed the age of 65 years and fulfill the following criteria:

- (i) The applicant must be residing within the Jurisdiction of Gaya Judgeship.
- (ii) The applicant desires to be re-employed in Gaya Judgeship.
- (iii) The applicant have not been re-employed in their respective Judgeship and
- (iv) The applicant have not applied for re-employment in their respective Judgeship.

The applicants must submit the following documents along-with their respective willingness on or before **15-02-2024**.

- (v) No objection certificate from respective Judgeship regarding submitting application for re-employment in Gaya Judgeship.
- (vi) Medical Fitness Certificate issued from the Civil Surgeon-cum-CMO.

The willingness along-with all relevant documents as mentioned above must reach to the office of the undersigned by **15.02.2024 till 05:00 P.M.**

The interaction of all eligible applicants shall be conducted on **16.02.2024 at 04:35 P.M.** for consideration of his/her recommendation for re-employment to the Hon'ble Court. The applicant must report in the office of the undersigned **at 04:00 P.M. on 16.02.2024.**

The concerned staff shall be further informed as per the kind approval and directions issued by the Hon'ble High Court, Patna.
