In pursuance to the notification issued by this Court vide reference 4^h cited and on the basis of oral interview conducted by the Interview Board on 26/06/2024 and 27/06/2024 for the candidates, who applied for the post of Junior Assistant and Office Subordinate (on contract basis) in POCSO Court, Jangaon, the Principal District Judge, Jangaon is pleased to issue the following Orders by appointing the under-mentioned candidates to work in Fast Track Sessions Courts for expeditious Trial and Disposal of Rape and POCSO Act cases, Jangaon as under:-

- The above individuals are entitled to consolidated pay as referred above every month as per existing rules from the date of their joining.
- The appointment of the above individuals is purely on contract basis and will be for a period of one year or till functioning of Fast Track Court or if at a later stage their services are found to be not satisfactory, they shall be terminated, whichever is earlier.



- 3. The above individuals shall report to duty before the Presiding Officer concerned within one week from the date of receipt of this Order, failing which the appointment would be deemed to have been canceled and no further correspondence will be entertained.
- 4. The above individuals are required to submit a Physical Fitness Certificate issued by a Medical Officer not below the rank of an Assistant Civil Surgeon at the time of reporting to duty and enter into a Deed of Agreement in the proforma prescribed as per terms of the conditions laid by the Hon'ble High Court in ROC.No.1996/E1/2033, dt: 21.04.2003 for submission to the Hon'ble High Court.
- 5. The contract of appointment shall automatically cease to be in operation unless a fresh proposal is made by the Undersigned and a fresh contract is entered into.
- 6. The place of posting shall not be considered as a permanent arrangement during the contract period and he/she may be deputed to such other place as may be directed by the appointing authority.
- If the above individuals desires to resign from their respective posts, they are permitted to do so by submitting one month prior notice to the Undersigned or shall pay one month's of their respective remuneration.
