

## **Minutes of meeting proceeding in respect of reconstituting Tamenglong Bar Association.**

### Resolution No. 1

### Resolution No. 2

### Resolution No. 3

The new office bearer shall also approach the Manipur Bar council for recognizing District Bar Association, Tamenglong as one the bar Association under Manipur bar Council.

#### Resolution No. 4

The new office bearers shall initiate necessary means for raising fund to meet the necessary expenses of the Bar.

#### Resolution No. 5

The new office bearer shall initiate a drive for maintaining a record of the Bar association members. Further, necessary form shall be maintained to record the membership of the Bar.

#### Resolution No. 6

Mr. D. Julius Riamei, Advocate shall donate Rs 10,000/- to the bar for utilizing in stationery and other necessary means of the bar. The said amount shall be transacted to the newly appointed treasurer namely Gaikhiuliu Riamei, Advocate.

#### Resolution No. 7

For the time being, membership fees shall not be collected. However, the house has decided that membership fees shall be collected from the members as and when the full operation of the Bar starts.

The temporary office of the District Bar Association, Tamenglong shall be at the residence of the new appointed secretary Mr. Kalangaipou Riamei, Advocate located at Duithanlaung Ward No. 5 House No. 25.
