WHEREAS, Hon'ble High Court of J&K and Ladakh, vide Notification No. 3167 of 2024/RG/NG-71(I), dated 23.12.2024 has declared fifteen days (15) winter vacations for District Courts in Kashmir Province and Courts located in District Kishtwar, District Doda and Courts at Batote, Gool, Banihal and Ukhral in District Ramban and Bani in District Kathua of Jammu Division in the UT of J&K as well as all Courts located in the UT of Ladakh with effect from 06.01.2025 to 20.01.2024 (both days inclusive).

WHEREAS by virtue of aforesaid notification of Hon'ble High Court of J&K and Ladakh, Principal District & Sessions Judges and Chief Judicial Magistrates of concerned districts were directed to make suitable arrangements for disposal of urgent Criminal business arising during the period of such vacations in the areas within their respective jurisdictions.

WHEREAS Hon'ble Principal District & Sessions Judge, Pulwama vide order bearing no. OB/864/PDSJP dated 24.12.2024 has also directed undersigned for making the arrangement for disposal of urgent criminal business falling within the domain of Judicial Magistrates of District Pulwama.


