Terms and Conditions:-

- 1.** The financial bid shall contain separates rates of all types items as per the description in (1) inclusive of all taxes, for each unit, in sealed envelopes, as well as the consolidated amount.
- 2.** The technical bid shall contain acopy of registration/Incorporation/ equivalent Certificate, Aadhar, PAN and GST Registration certificate along with declaration of experience.
- 3.** The bidder, who are distributors/ retailers shall be preferred over entities dealing in the items through other agencies.
- 4.** Every bidder must deposit a demand draft drawan on a Nationalised Bank / Scheduled Bank for Rs. 10,000/- only, in favour of the Nazarat Civil Court, Khagaria, as earnest money deposit.
- 5.** Validity of bid will be 15 days from the dated of opening of the bid.
- 6.** The earnest money of the bidder, whose quotations are not approved, shall be released after the award of the work to the successful tenderer. The successful bidder shall be

refunded earnest money deposit only after successful completion of the work, pending which the same shall be treated as Performance Security.

7. The contractor shall be competent to deliver the items immediately after the issue of supply order failing which the office reserves the right to get any other authorized party to carry out the supply.

8. The contractor shall completely indemnify against any liability, clamis, loses, or damages, sustained by it or them by reason of delay in supply or any breach of agreement, wrongful act negligence by the contractor or any of its employees engaged in supply of the items.

9. In the event of failure to supply the required items by the Contractor within resonable time, Civil Court, Khagaria shall have the right to terminate the contract at any point during its continuance.

10. Payment shall be made upon satisfaction regarding the items supplied. The Contractor shall raise invoice only after full delivery and all endeavour shall be made for payment within reasonable time from the date of receipt of the invoice. The Civil court , Khagaria shall have right to scrutinise the bills before processing the payments.

11. The office shall be entitled to deduct in accordance with applicable laws, GST or other deductions (as the case may be), from any payments made to the contractor.

12. The notice inviting tender and conditions for tender shall form part of agreement.

13. The competent courts in Civil Court, Khagaria shall alone have jurisdiction in respect of any matters pertaining to the tender & contract.
