Consequent upon to fill-up the vacant posts of Peon, I, passed the following order, with effect from 01/02/2025 F.N.

1	Shri Nikhil Gopalrao Gandre, Selected candidate at Sr.No.28 on the Select List of Peon of the Recruitment Process-2023.	Appointed on purely temporary basis to the post of Peon in the Pay Scale/Matrix : S-1 : Rs. 15000-47600/- and posted as such in the Court of 2nd Joint Civil Judge (Jr.Dn.) & J.M.F.C., Akot to a newly created post.

Notes:-

- 1) The above incumbent is hereby directed to take over the charge of his post and submit the detailed charge report to this office within 03 days from the date of joining.
- 2) The incumbent is given an understanding that his appointment is made purely temporary basis and his services will be terminated at any time without any notice or showing any causes. If he desires to resign his post, he should give one month's notice or forfeit one month's pay in lieu thereof.
 - a) He is further given an understanding that his appointment is subject to clearance of Police Verification Report.
 - b) He may join his appointment with effect from 01st February, 2025 F.N. or within 15 days from the date of receipt of this order. If he failed to join his appointment within stipulated period, his name/s will be struck-off from the select list and thereafter he shall not claim appointment as of right.
 - c) He should furnish undertaking and oath of allegiance before joining his appointment.
 - d) He should furnish declaration regarding Home Town as per Government Resolution, Finance Department No. TRA-1180-CR-316/Seva-8, dated 09.09.1980 & declaration regarding Non taking Dowry in view of Rule 3(4)(i) of the Maharashtra Dowry Prohibition Rules, 2003.

- e) He is further hereby given an understanding that he can not apply for Inter District Transfer prior to completion of two years service. If he prefer an application for the same, it will be simply filed.
- f) He is directed to appear before the Civil Surgeon, District Hospital, Akola for Medical Examination and to produce the Medical Certificate of fitness before joining his appointment. Prescribed form of medical examination is enclosed herewith for being filled-in by the candidate.
