Notes:-

- 01) The above incumbents are hereby directed to take over the charge of their post and submit the detailed charge report to this office within 03 days from the date of joining.
- 02) The above incumbents are given an understanding that their appointments are made on purely temporary basis and their services will be terminated at any time without any notice or showing any causes. If they desire to resign their post, they should give one month's notice or forfeit one month's pay in lieu thereof.
  - a) They are further given an understanding that their appointments are subject to clearance of Police Verification Report.
  - b) They may join their appointment/s with effect from 24 th February 2025 FN. or within 15 days from the date of receipt of this order. If they failed to join appointment/s within stipulated period, their name/s will be struck-off from the select list and thereafter they shall not claim appointment as of right.

- c) They should furnish undertaking and oath of allegiance before joining their appointment/s.
- d) They should furnish declaration regarding Home Town as per Govt.Resoln. Finance Deptt. No. TRA-1180-CR-316/Seva-8, dated 09.09.1980 & declaration regarding Non taking Dowry in view of Rule 3(4)(i) of the Maharashtra Dowry Prohibition Rules, 2003.
- e) They are further hereby given an understanding that they can not apply for Inter District Transfer prior to completion of two years' service. If they preferred application for the same, it will be simply filed.
- f) They are directed to appear before the Civil Surgeon, District Hospital, Akola for Medical Examination and to produce the Medical Certificate of fitness before joining their appointment. Prescribed form of medical examination is enclosed herewith for being filled-in by the candidate.
