Consequent upon to fill-up the vacant post of Junior Clerk, I, pass the following order, with effect from 21/02/2025 F.N.;

1	Tejaswini Walmikrao Gawande, Selected candidate at Sr.No.41 on the Select List of Junior Clerk of the Recruitment Process-2023.	Appointed on purely temporary basis to the post of Junior Clerk in the Pay Matrix : S-6 : Rs.19900-63200/- and posted as such in the Court of Civil Judge (Sr.Dn.), Akot to a vacant post of Shri A.G.Chhaliwal.

Notes:-

- 1) The above incumbent is hereby directed to take over the charge of her post and submit the detailed charge report to this office within 15 days from the date of joining.
- 2) The incumbent is given an understanding that her appointment is made purely on temporary basis and her services will be terminated at any time without any notice or showing any causes. If she desires to resign her post, she should give one month's notice or forfeit one month's pay in lieu thereof.
 - a) She is further given an understanding that her appointment is subject to clearance of Police Verification Report.
 - b) She may join her appointment with effect from 21st February, 2025 F.N. or within 15 days from the date of receipt of this order. If she failed to join her appointment within stipulated period, her name will be struck-off from the select list and thereafter she shall not claim appointment as of right.
 - c) She should furnish undertaking and oath of allegiance before joining her appointments. She is further directed to furnish returns of assessment and liabilities in the prescribed proforma under Government Resolution, GAD., No. Vashia-1214/C.R.26/11, dtd.02.06.2014, within two months from the date of joining.

- d) She should furnish declaration regarding Home Town as per Government Resolution, Finance Department No. TRA-1180-CR-316/Seva-8, dated 09.09.1980 & declaration regarding Non taking Dowry in view of Rule 3(4)(i) of the Maharashtra Dowry Prohibition Rules, 2003.
- e) She is further given an understanding that she can not apply for Inter District Transfer prior to completion of two years service. If she prefers an application for the same, it will be simply filed.
- f) She is directed to appear before the Civil Surgeon, District Hospital, Akola for Medical Examination and to produce the Medical Certificate of fitness before joining her appointment. Prescribed form of medical examination is enclosed herewith for being filled-in by the candidate.
