The Department/Police Stations concerned shall submit the applications u/sec. 164 of Cr. P.C. before the Judicial Officer concerned as per aforementioned order.

As regards other Centres of Courts, the controlling Judicial Officer, in-charge of Administration shall pass an order on the applications of the Police Stations/Department regarding appointment of Judicial Officer of their respective centre for recording statements u/sec. 164 of Cr. P.C.

This Circular shall be made applicable for recording confession statement of the accused as well as statement of witnesses u/sec. 164 of Cr. P.C.

All the Judicial Officers are directed to handover/forward the statement recorded by them u/sec. 164 of Cr.P.C. to the concerned Police Officer and obtain acknowledgment thereof.

It is clarified that there is no change in the Office Circular issued on time to time regarding appointment of concerned Lady Judicial Officers for recording statements of female victims or female witnesses as per Criminal Law Amendment Act, 2013, sub-section (5A) of Section 164 of Cr.P.C.

The above directions shall be followed scrupulously.
