Subject - Concession Leave

Notes :-

1. The Judicial Officers are not allowed either to prefix or suffix regular leave or Casual Leave to the Concession Leave availed by them.
2. The Judicial Officers who are granted two weeks concession leave will be liable to be recalled to duty in emergent circumstances and in that case they will not be eligible for grant of travelling and daily allowance.
3. Permission granted to all Judicial Officers to leave Head Quarters during the concession leave period.
4. The Judicial Officers while proceeding on Concession Leave will have to attend Holiday Remand duty assigned to them if such day of Holiday Remand Duty is falling on prefixed days of their Concession Leave. If they are unable to attend such holiday remand duty, they will have to make their own arrangements for attending their Holiday Remand Duty by other Judicial Officers and should submit the prior intimation of the same mentioning the names of the Judicial Officers who will attend in their places.
5. The Judicial Officers who will be holding the charge of Court of another Judicial Officer shall also attend Urgent Bail Applications (after office hours) as per notification bearing no. CMM/GC/16/2022 dated 29.04.2022 duty assigned to such Judicial Officer during his/her Concession Leave period.
6. **The Judicial Officers whose date of attending Jail Court duty is falling in between their Concession Leave period are exempted from attending the Jail Court duty on their scheduled dates and the Judicial Officers who will be holding the charge of such Judicial Officers are also exempted from attending the Jail Court duty on administrative grounds.**
7. The Judicial Officers who are due for transfer under Annual General Transfer – 2024 will have to attend the duty on their relieving date even though they may be on Concession Leave, in order to complete the procedure of handing over the charge.
