: Holding of Courts in Jail on regular basis to take up the cases

of Under-trial Prisoners

Reference

: 1. Letter No. A(Spl.)/Misc. /313/2009 dated14.10.2009 from the Hon'ble High Court, Bombay.

2. Letter No. A(Spl.)/Misc. / 264/2021 dated 05.07.2021 from the Hon'ble High Court, Bombay.

In view of the above referred letters, the following Judicial Officers are directed to attend the Daily Jail Court on regular basis to take up the cases of those Under Trial Prisoners who are involved in Petty Offences punishable upto three years or are keen to confess their guilt, in order to reduce the pendency of cases of Under Trial Prisoners. They shall attend the Jail Court alongwith the Original Record & Proceedings of the cases of the categories mentioned above, involving Under-Trial Prisoners, pending on the file of their own Courts. Hence, they are not required to keep such custody cases on the Board of regular Courts on the date of their Jail Court duty.

They shall attend Jail Court duty at <u>Arthur Road Jail, Byculla Jail & Taloja Jail</u>. They are permitted to frame charge against accused, record statement of accused U/sec.351 of BNSS and also entertain and dispose of Bail applications of the accused. They are also permitted to carry Laptops for smooth functioning of Jail Court.

If such custody cases are not available or kept then no need to attend the Jail Court and work to regularly in the court and report accordingly.

All the Judicial Officers are requested to those Judicial Officers who are attending Jail Court Duty except Borivali Court should complete their Jail Court in First Session and requested to attend their regular Court in Second Session and detail report of cases taken in the Jail Court be submitted immediately.

Henceforth, "In case the concerned Judicial Officer is on leave or otherwise absent on the date of Jail Court Duty assigned to him/her, the Judicial Officer holding the charge of his/her Court shall not attend the Jail Court Duty on that day".
