- It is reported that the Magistrates who have remand duty, often without taking consent of other Magistrate, seek permission to leave head quarter, Such practice shall be deprecated and Magistrate should refrain themselves from making such application without consent of other Magistrate. In such circumstances, the said Magistrate shall inform the undersigned without fail before leaving head quater.
- In case of any exigency, in which the Judicial Officer to whom remand duty is assigned as above, has to leave the head quarter without permission of the Hon'ble Principal District and Sessions Judge, Bhandara then any of the Judicial Magistrate, (F.C.) available at the head quarter shall attend remand and urgent matters.
- In view of Office Order issued by Hon'ble Principal District and Sessions Judge, Bhandara No.B-16(1)/604/1987 BHR, dated 11th August, 2017 regarding authorising the Judicial Officer for urgent Criminal matters during the absence of Judicial Officer of concerned court on working days and same arrangement to do the remand work and urgent matters on holidays 2nd and 4th Saturday's and Sunday's under the intimation the concerned Courts.
