- * Special Metropolitan Magistrates/Special Judicial Magistrates of Second Class will hold morning courts from 7.30 am to 10:30 am for 5 days in a week (Monday to Friday). They will be paid a consolidated honorarium of Rs.15, 000/- p.m.
- * The tenure of the appointed Special Metropolitan Magistrates/Special Judicial Magistrates of Second Class for the period of one year.

1. QUALIFICATIONS:

- i) The incumbent must have held any post in Andhra Pradesh/Telangana Higher Judicial Service or State Judicial Service and retired or resigned, or
 - ii) Who has held a post in the Andhra Pradesh Judicial Ministerial Service/ Telangana Judicial Ministerial Subordinate Service Rules not below the rank of Head Clerk / Superintendent of District Munsif Court and possesses a Law Degree or
 - iii) Who has held a post of Section Officer and above in the Andhra Pradesh/Telangana High Court Services and has a Law Degree or
 - iv) A non-practicing Advocate with a Practice in the Bar of not less than five years and who is above 45 years of age or
 - v) Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (Full test consisting of the Indian Penal Code and the Code of Criminal Procedure) conducted by the Andhra Pradesh Public Service Commission and who has exercised Magisterial Powers during his tenure of Service for not less than three years.
 - vi) A suitable retired Judicial Officer is preferred.

- vii Who has at least two years to attain the age of 65 years as on 01.07.2023.

2. DIS-QUALIFICATIONS:

A PERSON:-

- i) Who is a practicing Advocate or
- ii) Who is a member of any State or Local Authority, or
- iii) Who is a member of the State Legislature or the Parliament; or
- iv) A person who having held an office under the State or the Union Government or any Local Authority, was dismissed or removed or compulsory retired from Service subjected to any other major penalty for misconduct, or
- v) A person who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged with any offence constituting moral turpitude and proceeding are pending: or
- vi) A person adjudicated as an insolvent or an un-discharged insolvent or
- vii) A contractor or a businessman or one interested in a subsisting contract or any work being done for Central or State Government shall not be eligible.
- viii) The applications received prior to this notification/applications received after due date will not be considered.


3. REVOCATION OF POWERS OF SPECIAL MAGISTRATES:

- i) On appointment and while in service, powers conferred on a Special Metropolitan Magistrates/Special Judicial Magistrates of Second Class can be revoked if he/she failed to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate.
- ii) A Special Metropolitan Magistrates/Special Judicial Magistrates of Second Class stands automatically removed on attaining the age of 65 years.

4. APPLICATION AND OTHER INFORMATION:

- i) The appointing Authority reserves the right to cancel the notification without assigning any reason thereof,
- ii) No TA and DA will be paid for candidate for Journey performed in connection with recruitment.


