The Principal District and Sessions Judge, Ranga Reddy District at L.B.Nagar, is hereby directed to transmit the entire records (including Interlocutory Applications, Material Papers, Case Properties etc.) of transferred cases, duly indexing, making entries in the Physical Records and in the Software System and under proper acknowledgement to the respective Courts immediately, to enable the newly carved out Judicial Districts make functional w.e.f. 02.06.2022.

District & Sessions Judge, Ranga Reddy District at L.B.Nagar, is further informed that the cases made over (other than the cases identified for transfer on point of jurisdiction to other Districts) to the newly carved out Judicial Districts, be deemed to be transferred to them on point of jurisdiction as per Section 24 of the Civil Procedure Code and as per Section 407 of the Code of Criminal Procedure.

The Principal District Judges of the newly carved out Districts shall acknowledge the cases received by them to the Principal District Judge, Ranga Reddy District at L.B.Nagar under intimation to the High Court.
