They shall bring the following Original Certificates /Documents to be submitted at the time of Certificate verification

- i. Original certificates of academic qualifications, such as, marks list, pass certificates evidencing date of birth, community certificate issued by the competent authority in case of SC's, ST's and BC's and latest Economically Weaker Section (EWS) certificate issued by the competent authority in respect of EWS candidates.
- ii. The certificate in respect of BC's, shall show specifically the classification of the group.
- iii. Discharge certificate for Ex-servicemen candidates
- iv. Two sets of Photostat copies of certificates duly attested by Gazetted Officer are to be submitted.
- v. Certificate in respect of Local candidates in terms of the Telangana Public Employment (Organization of Local cadres and Regulation of Direct Recruitments) Order, 2018 vide G.O.Ms.No.124 General Administration (SPC-MC) Department, dated 30.08.2018 as specified in the general instructions. If certificates in proof of local candidature are not in accordance with these instructions, the applicant will be treated as Non-local.

- vi. In case of differently-abled persons, the certificate issued by the Medical Board Specifying the nature of disability and % of disability.
- vii. Copy of Aadhar Card shall be produced.
- viii. No objection certificate from the Employer (if employed anywhere)
- ix. For the applicants who have directly appeared for SSC/10th examination, as private candidates or studied in Open School mode without pursuing regular continuous study, they have to submit the Residence Certificate from the concerned Tahsildar for seven (7) years preceding the year of passing the VII examination in the prescribed format in terms of G.O.Ms.No.124 General Administration (SPC-MC) Department, dated 30.08.2018.
