As per the orders of the Hon'ble High court vide reference 2nd cited, the above individuals are appointed subject to result of their antecedents by the concerned police departments, that if any adverse remarks reported in the verification of antecedents, their provisional selection to the post shall be reviewed.

The seniority of the above approved candidates **will be fixed** as per their merit in view of the decision of the Hon'ble Supreme Court of India.


The appointments are covered by the **CONTRIBUTORY PENSION SCHEME** as per G.O.Ms.No.653, 654 and 655 Finance (Pen-I) Department, dated 22,09,2004 issued by the Government of Andhra Pradesh.

The individuals shall join duty within (30) days from the date of receipt of this orders or if evades to join the post it shall be treated as automatically cancelled and the names of the candidates shall be deemed to have been omitted from the list of approved candidates and they shall forfeit their right of appointment both for the present and the future. He/ She shall produce **physical fitness certificate** issued by a Government Doctor, not below the rank of an Assistant Civil Surgeon. The individuals shall produce all original certificates at the time of reporting duty in the concerned courts.

The above individuals shall, for the due and faithful performance of the duties attached thereto, deposit a sum of **Rs.10,000/- (Rupees Ten Thousand only)** in the shape of **Fixed Deposit** drawn in their favour towards security within a month from the date of joining duty in the said post. Non compliance is subject to Rule 22(c) of TJMSS Rules 2018.

The pay of the above mentioned newly appointed **Stenographer Grade-III** shall be fixed in the time scale of **Rs.32810-96890** Under RPS 2020 as per GO Ms. No. 51, Finance (HRM.IV) Department, dated 11.06.2021 issued by the Government.

The Presiding Officers concerned are hereby instructed to **verify** the original certificates of the individuals at the time of joining and **intimate** the joining of the individual to the undersigned.
