Note :-

The above appointments are made purely on **temporary basis** and their services are liable to be terminated without any notice or assigning any reasons.

The above appointment of the individuals is pending for verification of their antecedents by the concerned police and if any adverse remarks reported in the verification of antecedents and any information furnished by the individuals found to be false or incorrect in future, their appointments to the post shall be terminated and they shall be also liable for criminal prosecution.

The Selection and appointment of the candidates selected against BC-E vacancy that their selection against BC-E vacancy will, however, be subject to outcome of Civil Appeal No. 2628-2637/2010 pending consideration before the Hon'ble Supreme Court of India.


The seniority of the above approved candidates will be fixed as per their merit in view of the decision of the Hon'ble Supreme Court of India in the case of Bimlesh Tanwar Vs State of Haryana & Others.

The appointments are covered by the CONTRIBUTORY PENSION SCHEME as per G.O.Ms.No.653, 654 and 655 Finance (Pen-I) Department, dated 22,09,2004 issued by the Government of Andhra Pradesh.

The individuals shall join duty within (15) days from the date of receipt of this orders or if evades to join the post it shall be treated as automatically cancelled and the names of the candidates shall be deemed to have been omitted from the list of approved candidates and they shall forfeit their right of appointment both for the present and the future. He /She shall produce physical fitness certificate issued by a Government Doctor, not below the rank of an Assistant Civil Surgeon. The individuals shall produce all original certificates at the time of reporting duty in the concerned courts.

The pay of the above mentioned newly appointed Office Subordinate shall be fixed in the time scale of **Rs.19,000-58,850** Under RPS 2020 as per GO Ms. No. 51, Finance (HRM.IV) Department, dated 11.06.2021 issued by the Government.

The Presiding Officers concerned are hereby instructed to verify the original certificates of the individuals at the time of joining and intimate their joining to the undersigned, immediately.
