The appointment is covered by the **CONTRIBUTORY PENSION SCHEME** as per G.O.Ms.No.653, 654 and 655 Finance (Pen-I) Department, dated 22/09/2004 issued by the Government of Andhra Pradesh.

The individual shall join duty within (15) days from the date of receipt of this orders or if evades to join the post it shall be treated as automatically cancelled and the name of the candidate shall be deemed to have been omitted from the list of approved candidate and she shall forfeit her right of appointment both for the present and the future. She shall produce physical fitness certificate issued by a Government Doctor, not below the rank of an Assistant Civil Surgeon. The individual shall produce all original certificates at the time of reporting duty in the concerned courts.

The above individual shall, for the due and faithful performance of the duties attached thereto, deposit a sum of Rs.10,000/- (Rupees Ten Thousand only) in the shape of Fixed Deposit drawn in her favour towards security within a month from the date of joining duty in the said post. Non compliance is subject to Rule 22(c) of TJMSS Rules 2018.
