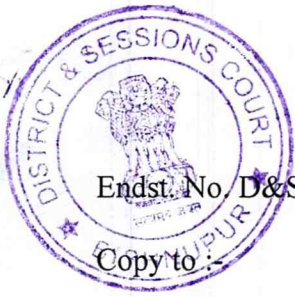
HYBRID HEARING / VIDEO-CONFERENCING OF CASES

STANDARD OPERATION PROCEDURE (SOP) FOR HYBRID HEARING OF CASES

1. Advocates/parties may appear for a case through Video Conferencing before a Court ;
2. Advocates/parties may enter the URL link in their web browsers or use the link in the VC application in order to appear before the Court ;
3. Advocates/parties may log in from his office/residence/conference room, etc., but not from a vehicle like car ;
4. No person is allowed to join the Court proceeding using the link, unless he/she is concerned ;
5. Advocates/litigants should not turn their camera off as long as they are connected in the Video-Conferencing Session ;
6. Participant(s) should enter their name or identity or item number properly before joining the case proceeding ;
7. Only one person may speak at a time or there will be overlapping of voices which will disturb the proceeding. The participant who is not interacting with the Court shall mute his/her audio to avoid disturbance/overlapping of sounds ;
8. Recording and/or publishing or sharing of the VC proceeding is strictly prohibited ;
9. All applicable decorum as maintained in a Courtroom shall be maintained by Advocates/Parties appearing through VC and they should be properly dressed ;
10. Participants should also ensure that they have strong internet connectivity so that the proceedings may be held smoothly.
