This petition is coming up on this day before me for hearing in the presence of Thiru. K.Rajesh, Learned Counsel for the petitioners and the Learned Public Prosecutor for the State and this Court passed the following:

#### ORDER

This petition has been filed by the petitioners/accused U/s.438 of Code of Criminal Procedure seeking anticipatory bail.

## 2. The Nitty-Gritty of the prosecution case is as follows:

On 23.04.2024 at about 4.30 p.m., the petitioners assaulted the complainant with stone and abused him with filthy language. Therefore the case registered against them U/s.294(b), 324 of IPC.

- 3. Heard both sides.
- 4. The points for determination is the can anticipatory bail be granted to the petitioners?

#### Answer:

- 5. The FIR and reply are persued. about 2 years ago, the complainant's son got married one Ranjana. Ranjana is daughter of accused NO.1. Over the said dispute the petitioners assaulted the complainant with stone and abused him with filthy language. the prosecution admitted that the victim has already discharged from the hospital. Having considering the family dispute between the complainant and the petitioner No.1 as well as the petitioner is being women, I inclined to release the petitioner on anticipatory bail.
- 6. Therefore it is ordered that in the event of arrest by the Respondent or on their surrender before the Learned Judicial Magistrate at Uthamapalayam within 15 days from the date of this order, the petitioners shall be released on bail on their each executing a bond for sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties each for like sum. The following conditions are imposed to the petitioners:-
- i) They shall appear before the SHO Gudalore North Police Station daily at 10.00 a.m., and 5.00 p.m., for the period of 25 days from the date of release on bail.
- ii) The petitioners shall not tamper with evidence or witnesses either during the investigation or trial.
- iii) The petitioners shall not abscond either during the investigation or trial.
- 7. On breach of any of the aforesaid conditions, the Learned Magistrate / Trial court is entitled to take appropriate action against the petitioner in accordance with law as laid down by the Hon'ble Supreme Court in P.K.Shaji Vs- State of Kerala (2005) AIR SCW 5560).

8. If the petitioners/accused thereafter abscond, a fresh FIR can be registered under Section 229-A IPC.
