This petition is coming up on this day before me for hearing in the presence of Thiru. S.Rakesh Harshan, Learned Counsel for the petitioner and the Learned Public Prosecutor for the State and this Court passed the following:

**ORDER**

This petition has been filed by the petitioner/accused U/s.438 of Code of Criminal Procedure seeking anticipatory bail.

**2. The Nitty-Gritty of the prosecution case is as follows:**

On 01.05.2024 at about 7.45 p.m., the petitioner assaulted the complainant with vehicle key and abused him with filthy language. Further he intimidated him with dire consequences. Therefore the case registered against them U/s.294(b), 323, 324, 506(ii) of IPC.

3. Heard both sides.

4. The points for determination is the can anticipatory bail be granted to the petitioner?

**Answer :**

5. The FIR and reply are perused. The incident took place over a money dispute between the complainant and the petitioner. The prosecution submitted that the victim has been discharged from the hospital. Having regard to the facts and circumstances of the case, I inclined to release the petitioner on anticipatory bail.

6. Therefore it is ordered that in the event of his arrest by the Respondent or on his surrender before the Learned Judicial Magistrate at Bodinayakkanur, he shall be released on anticipatory bail on executing a bond for sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties each for a like sum. Following conditions are imposed on him :-

i) The petitioner shall be appear before the SHO Bodi Town Police Station daily at 10.00 a.m., and 5.00 p.m., for the period of 25 days from the date of release on bail.

ii) The petitioner shall not tamper with evidence or witnesses either during the investigation or trial.

iii) The petitioner shall not abscond either during the investigation or trial.

7. On breach of any of the aforesaid conditions, the Learned Magistrate / Trial court is entitled to take appropriate action against the petitioner in accordance with law as laid down by the Hon'ble Supreme Court in P.K.Shaji – Vs- State of Kerala ( 2005) AIR SCW 5560).

8. If the petitioner/accused thereafter abscond, a fresh FIR can be registered under Section 229-A IPC.
